AGREEMENT Made the 5th day of October 1939

BETWEEN THE GAELIC ATHLETIC ASSOCIATION, LTD.,

having its registered office at Croke House, Clonliffe Road, in the

City of Dublin, Limited Company (hereinafter called " the Associa-

tion ") of the one part AND the Kerry County Board

of the Gaelic Athletic Association in the County

of Kerry and Denis J. Bailly

and Miceal O'Rourke in the County of Kerry

being the Chairman and Secretary respectively of the County Board

of the Gaelic Athletic Association of the County of Kerry

of the other part WHEREBY it is agreed by and between the

parties hereto as follows :—In consideration of the Association

handing over, allowing and permitting the County Board of the

Gaelic Athletic Association of the County of Kerry

(hereinafter called " the Board ") to retain the temporary posses-

sion of the Silver Cup known as the Sam Maguire Cup

they the said Denis J. Bailly and Miceal O'Rourke

for and on behalf of the Board do and each of them doth hereby

acknowledge that the said Cup is temporarily held by the said

Board with the permission of and for and on behalf of the said

Association AND that they and each of them will deliver up or

cause to be delivered up the said Cup to the said Association or

their nominees at any time on receiving one week's written notice

thereof requiring the Board so to do and that so long as the said

Board is permitted by the said Association to retain the custody

of the said Cup the Board will not part with the possession thereof

but will preserve and keep the same in good order, repair and con-

dition, and shall not suffer the same to be lost, damaged, injured,

destroyed or interfered with in any way. AND FURTHER that

in the event of the said Cup being lost, damaged, injured or destroyed (whether such loss, damage or destruction shall occur through any negligence on their part or on that of the said Board or otherwise howsoever), then and in that event they and each of them will at their own expense forthwith replace or make good any damage thereto or any loss thereby incurred by the Association. AND IT IS HEREBY FURTHER AGREED AND DECLARED by and between the parties hereto that the value of the said Cup shall be taken as the sum of £150. AND FURTHER that in the event of it being necessary to give any notice affecting the said Cup it shall be deemed sufficient service thereof to send same by Registered Post to the last known address of the Secretary for the time being of the Board.
